## Registration Requirements

All watercraft on Indigo Lake must meet the below listed registration requirements. The Property Owner of record must be present to register the watercraft and sign the Acknowledgement Form. When registration of ILE property owner-owned craft is complete, two Observation Stickers will be applied to the watercraft and a digital photo recorded in the database. These stickers must remain on the watercraft while on Indigo Lake. The TX Number will identify the property owner.

1. Current proof of liability insurance and ownership must be shown for each watercraft registered. Watercrafts that are registered must be owned by the property owner, or registered as a guest craft.
2. Guest, or rental, craft will be registered by the Property Owner of record and will display a clip-on numbered flag in lieu of the stickers to show they've complied with the Lake Rules. Guest registration is valid for one day unless otherwise authorized at the time of guest registration. A \$25 deposit will be refunded when the flag is returned.
3. Watercraft must have aboard all TPW required paraphernalia. These include: Life vests for every boater, fire extinguisher, orange 'down-tow' flag, mirror, horn or whistle, and running lights when appropriate.
4. Specifically exempted from registration are canoes, kayaks, and paddleboats.
